**IV.** Providing personal data is a necessary condition to achieve the purposes for which they were collected, and the refusal to provide them is tantamount to the inability to implement the Erasmus+ programme.

**V.** Personal data will not be disclosed to external entities, except in cases provided for by law (in particular: the National Agency of the Erasmus+ Programme and the European Solidarity Corps - Foundation for the Development of the Education System (FRSE), partner university and the receiving organization, if you are qualified to take part in the Erasmus + programme), as well as provided for in the agreements concluded between the University and service providers and technical/ organizational solutions (in particular IT service providers).

**VI.** Your personal data will be stored until the settlement of the Erasmus+ programme and until the archiving of the documentation is completed.

**VII.** You have the right to: access your data and rectify it, as well as the right to limit processing, object to processing - in the cases and under the conditions specified in the General Regulation.

**VIII.** Your personal data will not be subject to automated decision making and will not be profiled.

**IX.** Your personal data may be transferred to a third country depending on the country that you choose as the place of implementation of the Erasmus+ programme.

**X.** You have the right to lodge a complaint with the President of the Personal Data Protection Office when you feel that the processing of your personal data violates the provisions of the General Regulation.
